Rare opportunity to own a historic building prominently positioned on the Square directly across from the Hays County Courthouse in Downtown San Marcos. Originally constructed in 1885 as a saloon, the property features distinctive three-foot-wide stone demising walls, preserving its authentic historic character while offering an exciting opportunity for a modern transformation.

The property includes approximately 2,368 SF of finished space, consisting of 1,356 SF on the first floor and 1,012 SF on the second floor, plus an additional 255 SF of storage and 880 SF warehouse with 20-foot clear height.

With Downtown San Marcos continuing to benefit from the tremendous growth of Texas State University, now serving more than 44,000 students, this property presents an exceptional opportunity for an owner-user, investor, or developer to reposition a unique piece of San Marcos history.

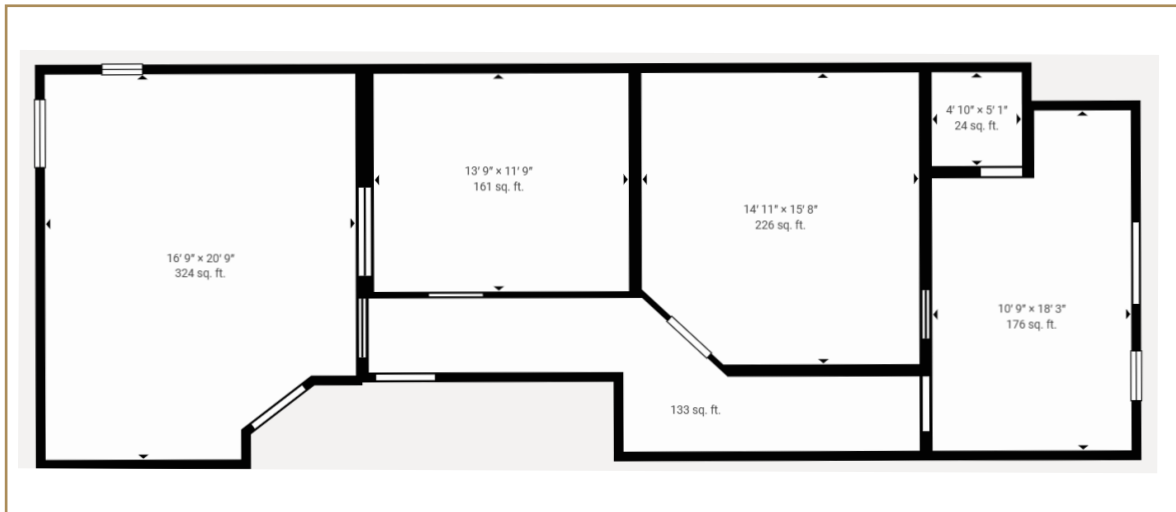
The building offers excellent potential for office, retail, medical, or other commercial uses, combining historic character with a highly desirable downtown location.

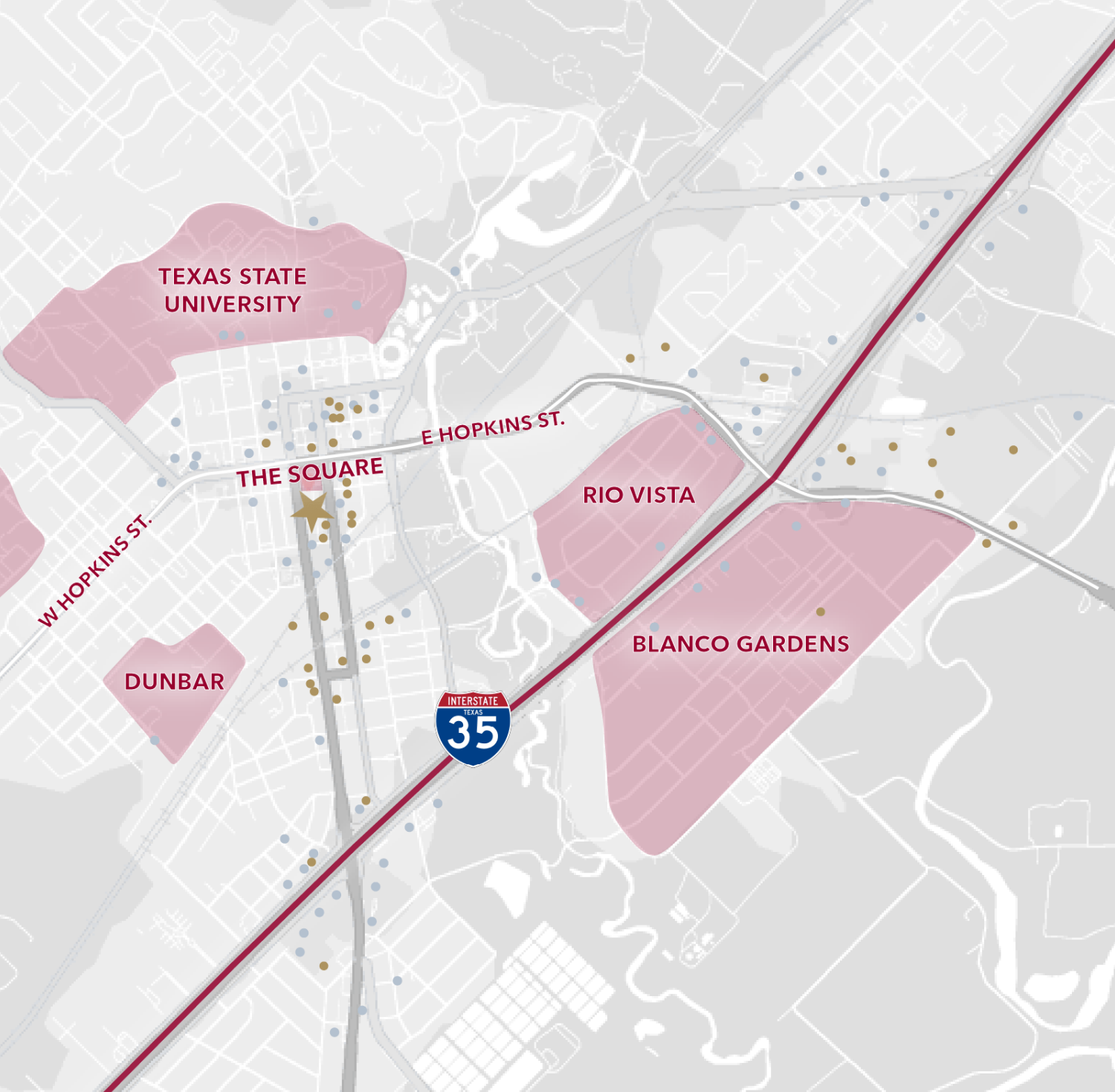

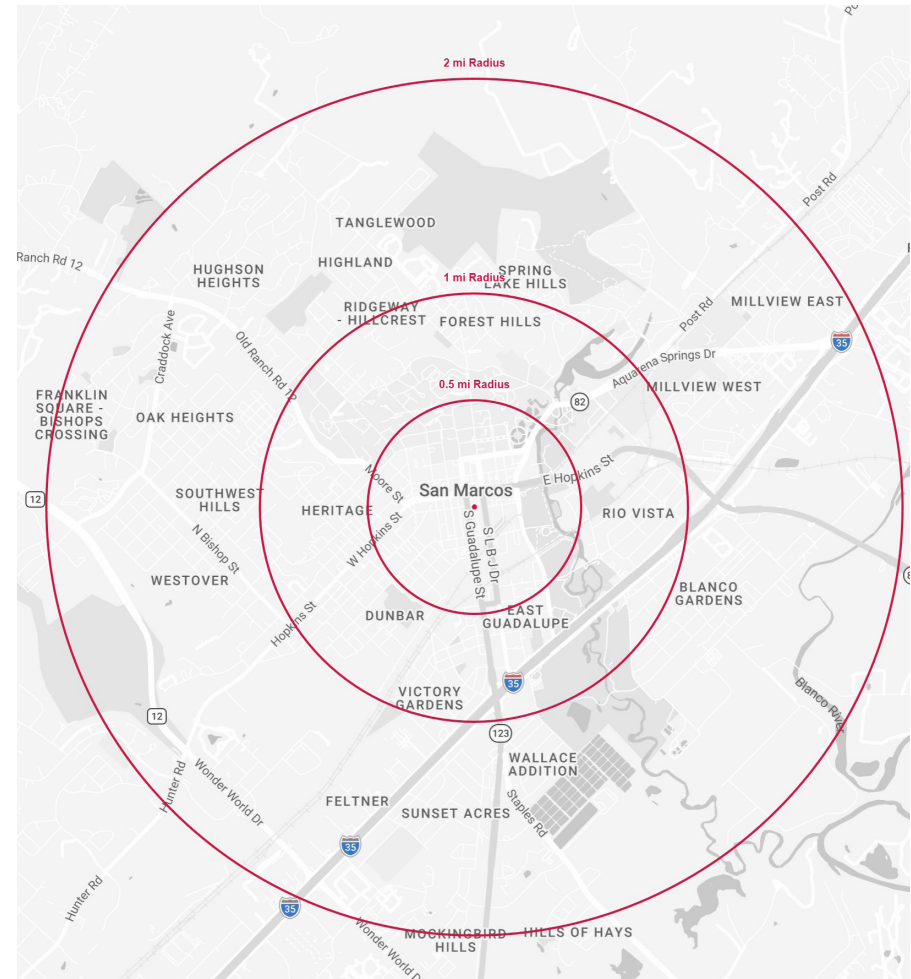
