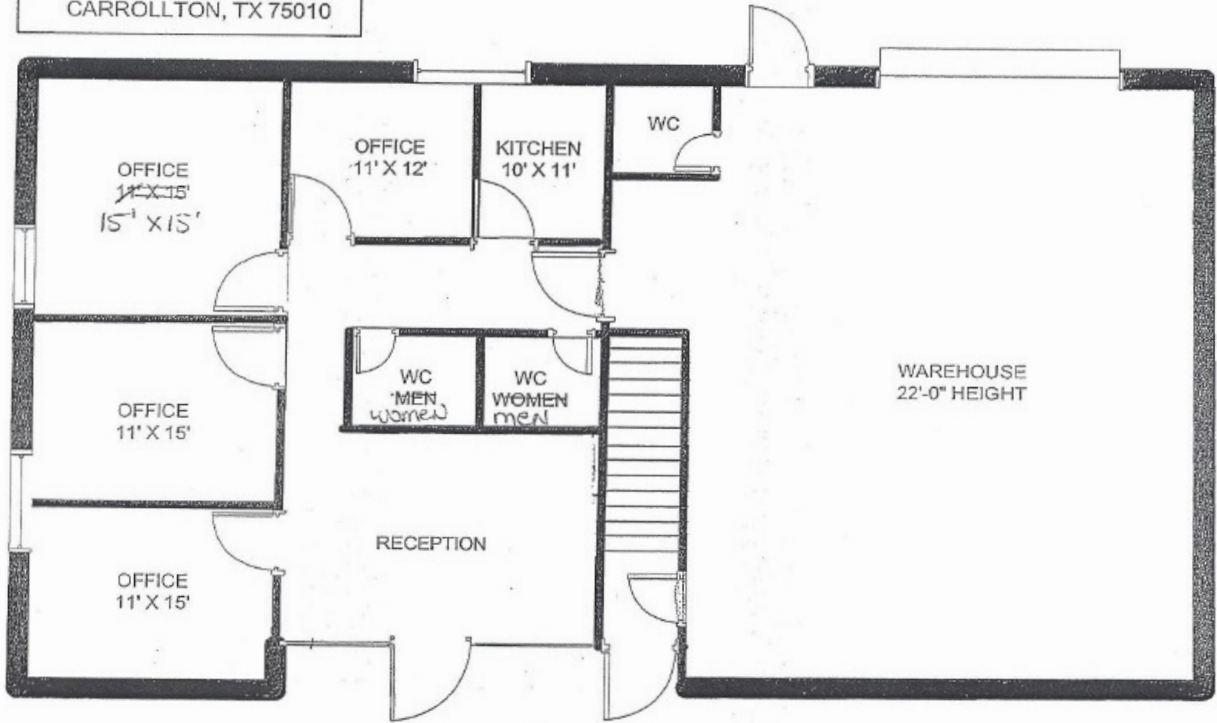

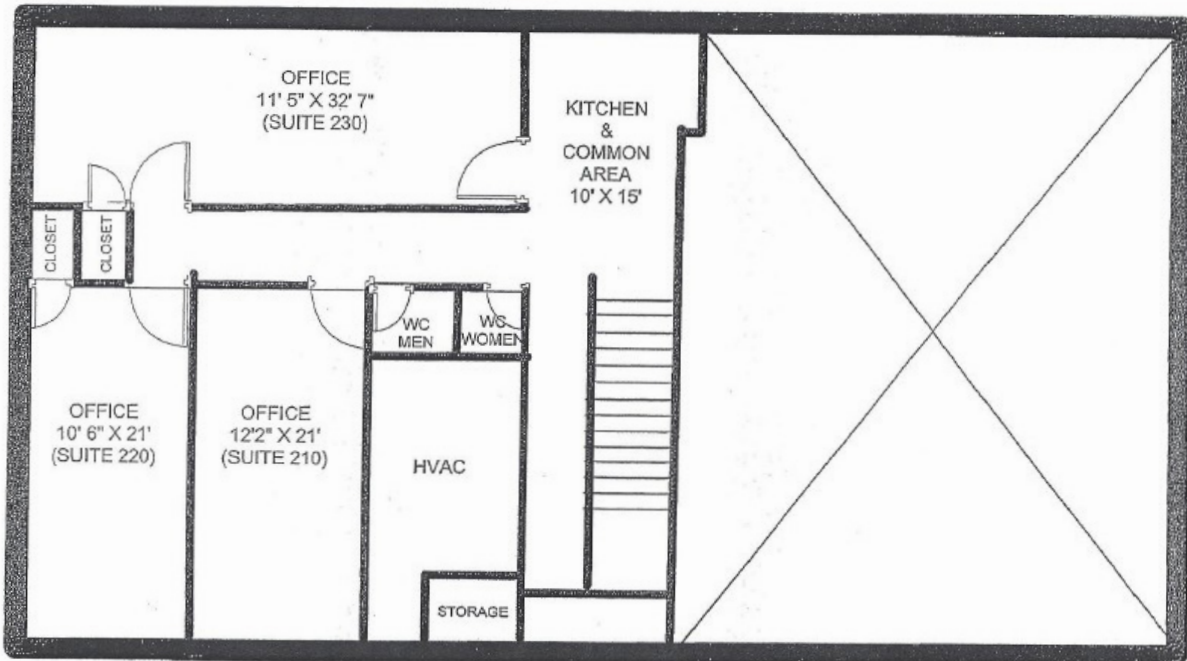
FLOOR PLANS

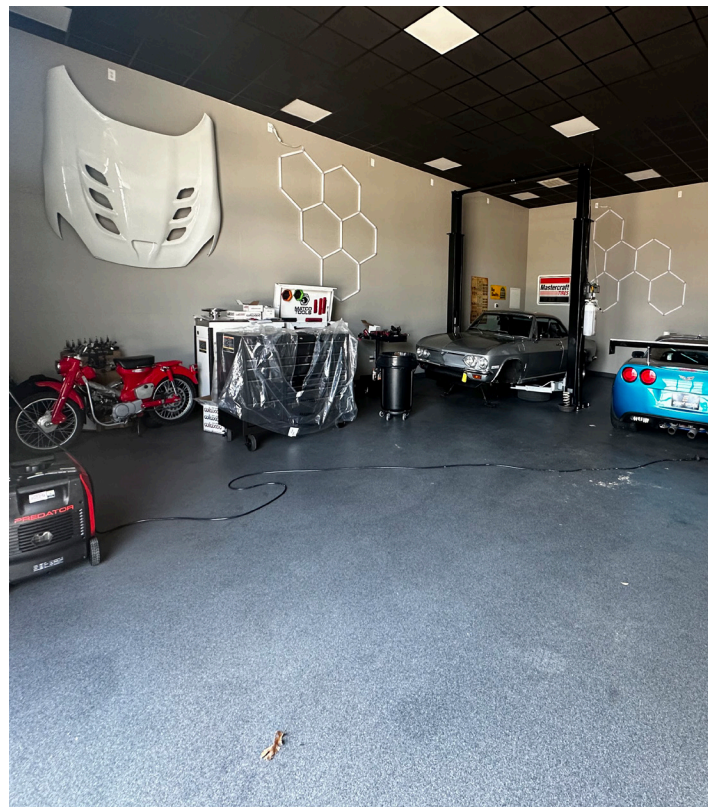
FLOOR PLANS
